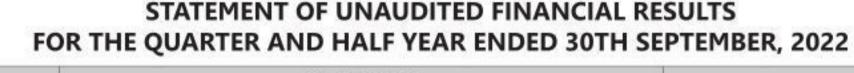

Matter is sub judice before the Rajasthan High Court.
